scheduled time of judging. It is expressly understood that exhibitors alone  
are responsible for the behavior of their dogs and/or children. Any  
exhibitor whose dogs and/or children create unnecessary disturbances or  
repeatedly engage in unsafe or disruptive behavior may, at the discretion  
of the Event Committee, be asked to leave the show site. In that case, no  
refund of any fees paid will be made. Exhibitors and dog owners are  
expected and required to clean up after their own dogs. Any person  
witnessing a violation of this rule must report it to the Event Committee.  
The Event Committee may ask any person violating this rule to leave the  
event grounds. No refund will be made if an exhibitor is asked to leave the  
grounds. Dogs may not be left unattended when crated in soft mesh  
crates. No dog may be left in an unlatched or unzipped crate. Dogs must  
be kept on leash except when being judged or when crated.

**ELIGIBILITY:** Dogs must be permanently registered with UKC, have a Temporary Listing (TL) number, or have a Limited Privilege (LP) listing number in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.

**Temporary listings will be available at the show site.**

**PAYMENT:** Payments may be made by cash, check, or money order; payable in U.S. funds to “MMBC”. No entry will be accepted without payment. Post-dated or returned checks do not constitute valid entry fees. MMBC will add a collection fee to the amount of each returned check. Exhibitors who repeatedly submit NSF entry fees may be put on a CASH ONLY basis.

**ROUTE TO THE SHOW:** From I-35W take the exit for MN-13 north. Turn right at Portland Avenue. Take the first left into the parking lot. Tails Up will be at the end of the second building.

**GENERAL INFORMATION:** Building will be open to exhibitors at 7am. Overnight security is not provided and no dog(s) may be left in the building overnight. Exhibitors may \*at their own risk\* leave crates and belongings overnight. Crating space is available indoors. **\*THERE WILL BE A POTLUCK \***

**REFUNDS:** No refund of entry fees will be made for entries cancelled after the closing date, except in the cases of bitches that come into season or injured dogs. In those cases, refunds may be obtained by providing a veterinarian's certificate to the Event Secretary before the start of the trials. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by a Judge, or barred from competition by action of the Event Committee or UKC. If, because of riots, civil disturbances, or other acts beyond the control of the host organization and it is impossible to open or to complete a show or trial, no refund of entry fee will be made. If, in the opinion of the host club, the well-being of dogs, exhibitors or spectators are at risk due to extreme weather conditions, such as, but not limited to snowstorms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.
