NOTICE TO EXHIBITORS: Dogs may arrive any time prior to their scheduled time of judging. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In that case, no refund of any fees paid will be made. Exhibitors and dog owners are expected and required to clean up after their own dogs. Any person witnessing a violation of this rule must report it to the Event Committee. The Event Committee may ask any person violating this rule to leave the event grounds. No refund will be made if an exhibitor is asked to leave the grounds. Dogs may not be left unattended when crated in soft mesh crates. No dog may be left in an unlatched or unzipped crate. Except when being judged or when crated, dogs must be kept on leash.

ELECTRIC TIMERS WILL BE USED FOR THE RALLY TRIALS

ELIGIBILITY: Dogs must be permanently registered with UKC,
have a Temporary Listing (TL) number, or have a Limited
Privilege (LP) listing number by the closing date and time in order
to enter. No exceptions will be made. Entries for ineligible dogs
will be returned.

Temporary listings will be available at the show site.

PAYMENT: Payments may be made by cash, check, and money
orders, payable in U.S. funds to "MMBC". No entry will be
accepted without payment. Post-dated or returned checks do not
constitute valid entry fees. MMBC will add a collection fee to the
amount of each returned check. Exhibitors who repeatedly submit
invalid entry fees may be put on a CASH ONLY basis.

REFUNDS: No refund of entry fees will be made for entries
cancelled after the closing date, except in the cases of bitches
that come into season or injured dogs. In those cases, refunds
may be obtained by providing a veterinarian's certificate to the
Event Secretary before the start of the trials. Entry fees shall not
be refunded in the event that a dog is absent, disqualified,
excused by Veterinarian or Judge, or barred from competition by
action of the Event Committee or UKC. If, because of riots, civil
disturbances, or other acts beyond the control of the host
organization it is impossible to open or to complete a show or trial,
no refund of entry fee will be made. If, in the opinion of the host
club, the wellbeing of dogs, exhibitors or spectators is at risk due
to extreme weather conditions, such as, but not limited to snow
storms, hurricanes, lightning, or extreme heat, the host club may
cancel or stop a show or trial before completion. No refunds will
be made in such cases.

ROUTE TO THE SHOW: From I-35 - Take the CR-1 exit, EXIT
66, toward Dundas/Montgomery. Turn right onto Millersburg Blvd
W/CR-1. Turn left onto Independence Ave/CR-4. Turn left onto
Shieldsville Blvd/MN-21. Turn right onto 140th St W/MN-99.
Continue to follow MN-99. Turn left onto S Plut Ave. S Plut Ave is
just past S Waterville Ave. Beer Oil & Tire is on the corner. If you
reach S Park Ave you've gone a little too far. From 169 - Turn
right onto W Broadway Ave/MN-99. Continue to follow MN-99 E.
MN-99 E is just past W Park Row St. Domino's Pizza is on the
corner. If you are on N Minnesota Ave and reach W Chestnut St
you've gone a little too far. Turn right onto S Plut Ave. S Plut Ave
is just past S Park Ave. Beer Oil & Tire is on the left. If you reach
S Waterville Ave you've gone a little too far. 320 S PLUT AVE is
on the right. If you reach the end of S Plut Ave you've gone about
0.1 miles too far
