No dog may be left in an unlatched or unzipped crate. dogs must be kept on leash except when being judged or when crated.

ELIGIBILITY: Dogs must be permanently registered with UKC, have a Temporary Listing (TL) number, or have a Limited Privilege (LP) listing number by the closing date and time in order to Pre- enter. Entries for ineligible dogs will be returned.

PAYMENT: Payments may be made by cash, check, or money orders payable in U.S. funds to “**MMBC**”. No entry will be accepted without payment. Post-dated or returned checks do not constitute valid entry fees. MMBC will add a collection fee to the amount of each returned check. Exhibitors who repeatedly submit invalid entry fees may be put on a CASH ONLY basis.

REFUNDS: No refund of entry fees will be made for entries cancelled after the closing date, except in the cases of bitches that come into season or injured dogs. In those cases, refunds may be obtained by providing a veterinarian’s certificate to the Event Secretary before the start of the trials. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Event Committee or UKC. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made. If, in the opinion of the host club, the well-being of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.
